Commissioner Smith: Judge, I think Valerie could just give us a brief description of the plan going forward. Valerie Amason: This is for the preservation and restoration of the County Clerk's Archive Records, some of our records have been digitized but they are not in the system where people can look them up and we are hoping to get those indexed. We also have some old Probate records that the old Wills, which we have to keep forever, they are starting to deteriorate and they really need to be scanned

and preserved. We have condominium records that have never been scanned. Commissioner Casterline: Do you have plans of doing that

Valerie: I don't have my records.

Judge Mills: They are in Michigan, I have to get them back here, but we have to have a place to put them.

**Commissioner Smith:** But going forward you're going to follow the law from the Local Government Code, Section 118.025, as is mentioned here, and it will be done in accordance with that Code?

Valerie: Yes sir.

#### COUNTY ROADS

5. Motion was made by Commissioner Chaney and seconded by Commissioner Casterline to approve Order #0-10-2019, an Order to clarify action taken by the Commissioners Court of Aransas County, TX as recorded in the minutes of a Special Meeting on August 17, 1977. The action taken was to close and abandon an unimproved 100' wide platted roadway lying between Lot 1, Tract 17, and Lot 23, Block 4 of West Terrace Acres Subdivision, Unit 1. This order also clarifies the action to state that the North One-Half of said Street would attach to Lot 23, Block 4 and the South One-Half of said Street would attach to Lot 1, Tract 17 of said West Terrace Acres Subdivision, Unit 1.

Both portions of said roadway have been occupied and improved since August 1977. This Order will ratify the previous action.

**Commissioner Laubach:** Could someone just give me the kindergarten version of what this Preliminary Budget change means so we can have it on the record? I see numbers but I just really don't know where they came from and why it all happened.

Suzy Wallace: As of July 29<sup>th</sup>, the amount that was going into the unreserved fund balance with was \$39,782, with the changes that we made from the last Commissioners' Court and any payroll changes, there are no other payroll changes happening at this time, but all of those... Commissioner Laubach: What kind of changes? Suzy Wallace: Step increases, there was an unfunded mandated change to County Court at Law, there were just few, they were basically...

**Commissioner Laubach:** Unfunded mandate change, State required, uh huh, so there were just a few routine things that came to your attention between the last jargon and the new one?

Suzy Wallace: Yes.

**Commissioner Laubach:** And that effect is, instead of going into the reserves at \$40,000 we are going to go in at about \$150,000

Suzy Wallace: \$154,474.

**Commissioner Smith:** Suzy, just as a matter of note, this particular thing that you passed out, it says unreserved fund balance affected, that should be the change in the unreserved fund balance. That would make it a little more understandable.

Judge Mills: Ok, any more questions? (none)

There were none.




Question. Motion carried unanimously.
