#### Honorable Commissioners' Court:

Several months ago, County Attorney Richard Bianchi constructively resigned his office and has been serving in a holdover capacity at the pleasure of this Honorable Court until you appoint a successor.

Now that the primary elections are over, we believe this is an appropriate time to suggest a transition plan for your consideration. Although our plan can be implemented under the existing authority and budget of County Attorney Richard Bianchi, it is fully understood that Commissioners' Court has the authority to alter that plan at any time by appointing a successor to Bianchi.

In all probability, Kristen Blanford will be the next Aransas County Attorney. Although Ms. Blanford's election does not require her to take office until January 1, 2015, an orderly and gradual transition would best serve the needs of Aransas County citizens. Effective March 31, 2014 Ms. Blanford will begin a temporary assignment as Assistant County Attorney, working an average of 20 hours per week. This temporary arrangement will allow Ms. Blanford to fulfil her existing obligations to her law firm and clients. As she winds down her law practice, the hours she will work as Assistant County Attorney will proportionately increase. At some point this year, Ms. Blanford anticipates that the requirements of her private law practice will be reduced to a degree that she will be able to advise Commissioners' Court that she is available for full-time assignment as County Attorney. Again, we both recognize fully that when and if Ms. Blanford is appointed County Attorney prior to January 1, 2015 is solely within the discretion of Commissioners' Court and Ms. Blanford.

Given that any newly elected official would welcome the opportunity to learn the office and staff before assuming full responsibility, this transition plan enables Ms. Blanford to begin assuming her county duties while completing her private business obligations. The benefits to the county include ensuring a smooth transition and preparing Ms. Blanford for taking the Aransas County Attorney position as soon as practical.

Finally, we are mindful that cases undertaken by the County Attorney's office during Richard Bianchi's service will create conflicts when he assumes the position of County Court at Law Judge. Although this transitional difficulty is a common occurrence whenever a new judge assumes the bench, every effort will be made to minimize that problem by transitioning to Kristen Blanford as County Attorney several months prior to the end of the year. Although, it cannot be predicted when her private law practice obligations will allow the complete changeover, Commissioners' Court will be kept apprised of that progress by Ms. Blanford.

Hopefully, this course of action will assist Commissioners' Court in meeting its responsibilities as well as provide the smoothest transition for the citizens of Aransas County. We welcome the opportunity to discuss current circumstances and to keep the public fully advised. To that end, time has been requested on your March 24<sup>th</sup> Agenda for discussion and any action you deem necessary.
