County Auditor Kirk read the August 2014 fee reports (report inserted).

Human Resources Director Pat Rousseau thanked everyone for participation in the open enrollment that is 90% completed. There was a 150% increase in those taking the dental insurance.

Judge Mills commended Sheriff Mills and the jail for seven (7) straight years of State Jail compliance.

County Judge's Executive Assistant Linda Garcia reported receipt of a \$300,000.00 grant from the Texas Department of Agriculture for a new community program.

Judge Mills also reported Cedar Bayou is going well. Captain Tommy Moore (Navigation District Commissioner) has offered his boat to transport the public to see the final day of unplugging.
