Under the circumstances, Chaney recommended the Court look at alternatives for rural transportation. This change will take place within the next two (2) or three (3) months. Chaney also

reported a meeting with TXDOT will be held on Thursday and he should have more information at that time.

Judge Mills reported he and Commissioner Smith made a trip up to Port O'Connor to check out the progress in cleaning up the recent oil spill. The kick-off for Cedar Bayou will occur tomorrow (April 15th) and he saw no reason to delay it.

County Treasurer Cartwright reported on the Courthouse landscaping project that is in progress. This project was made possible through cooperation of Commissioner Stiles, Ms. Cartwright and the Master Gardeners.

Tax Assessor-Collector Cox stated her office is having a software conversion and will be closed two (2) or three(3) days next week. Director of Environmental Health Jackson stated he spoke with FEMA regarding the questions the County had on the new maps they are working on. FEMA replied they would have an answer soon. Jackson also reported the house in the 700 block of North Doughty has been boarded up.
