# ITEMS FOR DELIBERATION AND/OR ACTION

#### MINUTES

Motion was made by Commissioner Casterline and seconded by Commissioner Smith to approve the minutes of the Budget Workshop Meetings of August 8 and 9, 2012, the Regular Meeting of August 13, 2012, Special Meeting of August 13, 2012, Public Hearing of August 20, 2012 and the Special Meeting of August 20, 2012 with one addition to the August 20<sup>th</sup> meeting concerning the Elected Officials Salaries.
