ORDER - FLOOD CONTROL

Bob Henderson with Dain-Rauscher told the Court Aransas County has a AA rating. The certificate of obligation will be at 3.6% for 20 years. Due to current events, the cost to the County will be \$385,000.00 instead of the anticipated \$400,000.00.

Motion was made by Commissioner Smith and seconded by Commissioner Chaney to approve an order authorizing the issuance of an amount not to exceed \$5,500,000.00 "Aransas County, Texas Combination Tax and Revenue Flood Control Certificates of Obligation, Series 2011."

GRANT APPLICATION - COASTAL MANAGEMENT PROGRAM

Motion was made by Commissioner Smith and seconded by Commissioner Cole to authorize submission of a 60/40 grant application to the Texas General Land Office Coastal Management Program for acquisition of up to 107 acres of land adjacent to the east right-of-way of State Highway 35 between Lamar Point and Holiday Beach East and to authorize the County Judge to act on behalf of Aransas County in all matters related to the application and grant contract, if the project is among those selected for funding.

GRANT APPLICATION - COASTAL MANAGEMENT PROGRAM

Motion was made by Commissioner Smith and seconded by Commissioner Cole to authorize submission of a 60/40 grant application to the Texas General Land Office Coastal Management for acquisition of 50 acres of land approximately 0.8 miles west of the intersection of State Highway 35 Bypass and FM 3036, and to authorize the County Judge to act on behalf of Aransas County in all matters related to the application and grant contract, if the project is among those selected for funding.

REVENUE SHARING - REFUGE

Motion was made by Commissioner Casterline and seconded by Commissioner Chaney to approve distribution of \$102,716.00 of U.S. Fish and Wildlife Service Refuge Revenue Sharing Act annual payments to local governments for lands under their administration for fiscal year 2010 received in 2011 for further review.

Motion was made by Commissioner Chaney and seconded by Commissioner Smith to approve public official bond continuation certificate on Joyce Reyes, Deputy County Clerk.

ELECTED OFFICIALS SALARIES FOR 2012

Motion was made by Commissioner Smith and seconded by Commissioner Chaney not to give elected officials a raise for 2012 budget year.

Question. Motion carried unanimously.

It is so ordered.

PROPOSED 2012 BUDGET

Discussion was had regarding the proposed 2012 budget. Commissioner Smith suggested going with Alternate Plan 1 for health insurance. This plan would raise the deductible from \$250.00 to \$300.00; raise copay amounts to \$25.00 for office visits and \$90 for emergency room resulting in a \$13.00 savings to the County of \$13.00 per employee. It was suggested the County change the renewal dates to allow for accurate costs during budget hearings.

Motion was made by Commissioner Chaney and seconded by Commissioner Smith not to adopt the budget as presented but adopt a budget that would be offset by revenues.

Commissioner Chaney stated he would support a % cent tax increase. Commissioner Cole stated he would like to go with the effective tax rate. Commissioner Smith wanted no increase in taxes and a raise for employees only. Commissioner Casterline wanted a raise for all employees.

The motion failed with only Commissioner Chaney voting for it.

Commissioner Casterline asked the Court to revisit elected officials salaries. County Attorney Bianchi stated it would be permissible since the budget was being discussed.

Motion was made by Commissioner Casterline and seconded by Commissioner Chaney to reconsider elected officials salaries.

Question. Motion carried unanimously.

It is so ordered.

County Clerk Friebele reminded the Court they have not received a raise in two years; they are taxpayers also; and the Court is considering lower health care benefits for employees.

District Clerk Heard stated the Court should take away raises for department heads also since they already make more than most elected officials and receive longevity pay.

Both Sheriff Mills and Tax Assessor-Collector Cox agreed with Ms. Heard.

County Attorney Bianchi stated he is in a different situation from most other elected officials in that he is allowed to continue his law practice and bring in additional income;

however, he agreed that elected officials should receive a raise.

Motion was made by Commissioner Casterline and seconded by Judge Mills to approve a 3% raise for elected officials.

Question. Motion carried unanimously.
