Ernest Galindo, Assistant Director, Risk Control Services with Texas Association of Counties was present to introduce a new program "TAC RISK MANAGEMENT POOL RISK CONTROL REIMBURSEMENT PROGRAM".

Ernest introduced Terry Pickering, former Sheriff of Bastrop County, recently hired by TAC and the person who will be servicing Aransas County as the Law Enforcement Control Consultant.

Ernest went on to explain the program and how it could benefit Aransas County, the application process and the eligible projects that could be funded through this process.

Question. Motion carried unanimously. It is so ordered.
- 4. Motion was made by Commissioner Smith and seconded by Commissioner Casterline to approve authorizing the County Judge to sign a Real Estate Contract between Rocky C. Sanders, Jack F. Sanders, Sheri S. Ortiz and Aransas County for the purchase of a 1.436 acre tract of land commonly known as 1110 Prairie Road in Fulton, Texas 78358.

to issue and the County Treasurer to disburse a \$2,500 Earnest Money Check made out to Stewart Title to accompany the real estate purchase contract for 1110 Prairie Road in Fulton, Texas.

Motion was made by Commissioner Chaney and seconded by Commissioner Stiles to approve authorizing the County Judge to sign an Intergovernmental Lease Agreement with Coastal Plains Community MHMR on county-owned vacant land per the two entities' December 18, 2015 Memorandum of Understanding. Question. Motion carried unanimously. It is so ordered.
- 7. Motion was made by Commissioner Smith and seconded by Commissioner Casterline to approve authorizing the County Judge to sign a Memorandum of Lease between Bahia Air, LLC and Aransas County for Veritas Title. Question. Motion carried unanimously. It is so ordered.
- 8. Motion was made by Commissioner Smith and seconded by Commissioner Chaney to approve authorizing the County Judge to sign a Ground Lease Estoppel Certificate and Agreement between Prosperity Bank, Bahia Air LLC and Aransas County to verify tenant's lease assignment and loan collateral consisting of tenant's assets in the leased premises.
