CITIZENS TO BE HEARD

There were none.

PRESENTATIONS

Rockport Arts District Designation introduced by Jennifer Day. She stated that she is here today to talk about the Cultural Arts District Designation for Rockport. She is asking the Court for their continued support through a resolution approval that will be attached to an application for the Texas Commission of the Arts (TCA) ultimate approval. We are sponsored by the Rockport Heritage District Association. They are in the process of redoing their bylaws and changing their name, we will be a part of that and our title will be the Rockport Arts District. In 2005 there was a bill passed for these particular designations with a goal of promoting economic development and community revitalization. Rockport is unfortunately losing local artists to death and we need to attract more artists to this area. Incentives for Art Districts include tax credits for preservation of cultural properties, enhancing property values, encouraging business and job development, tourism, and housing.

Jennifer explained that the five million in grant money has already been distributed for this year. We are asking for help from the County and the City of Rockport to help fund at this time:

- 1) hiring a grant writer \$5,000
- 2) website design \$2,500
- 3) required (in order to qualify) audio/visual \$2,500 We will then submit our application for designation and when accepted, we will then be able to apply for the grants.
