REPORTS FROM COMMISSIONERS, ELECTED OFFICIALS & DEPARTMENT HEADS WHEREIN NO ACTION WILL BE TAKEN

Fee Report read by Lezlie Kirk, County Auditor.

Alma Cartwright, County Treasurer added that on the Accounts Payable today, we have the U.S. Fish and Wildlife distribution that the Commissioners' Court had already approved according to a letter stating the amount would be the same as the previous year in the amount of \$121.000.00, but the letter came back with the check and it is actually \$113,000.00 instead of the \$121,000.00 as stated in the previous letter.

Pat Rousseau, Director - Human Resources Department stated that there was a powerful thunderstorm in Nueces County where a Halo Flight Air Ambulance was trying to land there with a sick child coming from up from the valley and going to be transferred to Driscoll Hospital. They could not land there because of the weather so they came over to the Aransas County Airport. Bill Shockley met the aircraft in the rain. Robert Garcia and Hai Tran assisted Mr. Geer and they

brought the child into the building. The ambulance arrived shortly thereafter and the child and his family were transported to Driscoll successfully. Ms. Rousseau wanted to commend Michael Geer and his staff.

Michael Geer, Airport Manager, stated that the airport terminal was very busy that day. All of the people were very respectful when they brought the child through and the child was not alarmed or upset by the crowd and remained calm as he was kept in the conference room and made comfortable. We also received nice letters from the folks over at Driscoll thanking all who were involved.

Commissioner Smith stated that the State Legislature, currently in session, has decided to raise the homestead exemption to support local government. It is amazing that these people think that the public is so naïve and that they continue to promote these unfunded mandates.

Commissioner Stiles reports that the new causeway bridge is now up and she commends TXDOT for their response to some of the problems that arose. They removed twelve of the barricades impairing vision on the south bound sides. They put up a new LED stop sign and are going to install rumble strips to slow the traffic making people aware that construction is going on. She points out that the public needs to be very careful because there is a low profile, on the side, on the railing. She also commends Martin Hoerst for his accommodating involvement with the issues.

The court entered into closed session at 9:27 a.m. to discuss and review potential litigation issues and other matters covered by the attorney-client privilege pursuant to Texas Government Code Section 551.071(1(a); and to discuss real estate negotiations, including Pathways Projects pursuant to Texas Government Code Section 551.072; and resumed Open Meeting at 9:58 a.m. with all members present, and further proceedings were had and done to wit:
