### Filing Requirement per Property Code 12.001(b) and 12.001:

Instruments must have original signature and proper acknowledgement

#### Filing Requirement per Local Government Code 193.012:

After recording, original documents shall be returned to the person who filed them.

#### Filing Requirements and Specifications per Property Code 11.03(2):

Instruments conveying an interest in real property that do not include the mailing address of each grantee shall be subject to a penalty filing fee equal to the greater of \$25 or TWICE the statutory recording fee for the instrument paid.

#### Filing Requirements and Specifications per Local Government Code 191.007(a-h):

A "page" is considered to be one side of a sheet of paper and MUST

- be no wider than 8-1/2 inches and no longer than 14 inches;
  - have a sufficient weight and substance so that printing, typing, or handwriting will not smear or bleed through;
  - be printed in type not smaller than eight-point and be suitable for reproduction;
  - have a clearly identifying heading at the top of the first page to identify the type of legal document;
  - be clearly legible;
  - have names legibly typed or printed immediately under each signature;
  - not be a negative print (white printing, typing, or handwriting on a dark background); and
  - not have riders or attachments that are larger in page size than the main document (and only one rider or attachment is allowed per instrument).

Instruments that fail to meet any of the requirements above shall by subject to a penalty of TWICE the regular filing fee or recording fee provided by statute for that page.

#### **FEES FOR VITAL RECORDS**

**Plain Copies may NOT be issued for Vital Records**. Vital records, such as birth or death certificates, are legal documents that are used to prove a person's identity. **To get a certified copy of a vital record, you must be a person qualified to do so and submit a completed application** which includes acceptable identification, the correct fees, and, in some cases, supporting documentation.

Birth records are closed to the public for 75 years. Likewise, death records are closed for 25 years.

Per Family Code 2.201: If a marriage ceremony has not been conducted before the 90<sup>th</sup> day after the date the license is issued, the marriage license expires (and can no longer be used).

The County Clerk's office can provide additional marriage license information, regulations, and requirements including marriage by proxy, absent applicant, marriage to an incarcerated person, marriage of a deployed soldier, or soldier deployed to a hostile zone.

- is a member of the armed forces of the United Sates on active duty,
- performs work for the United States Department of Defense as an employee/contract worker, or
- obtains a written waiver from a judge of a court with jurisdiction in family law cases, a justice of the supreme court, a judge of the court of criminal appeals, a county judge, or a judge of a court of appeals.
