Prior to award, the Contract Developer (purchaser) must check the divestment lists to determine if the potential awardee is in violation of this requirement. The divestment lists are maintained by the Texas Safekeeping Trust Company and posted to the CPA website located at Comptroller.Texas.Gov. If the potential awardee is on the list, the contract may not be awarded to that vendor. 86th Legislative Session of Texas House Bill (HB) 793.

Prior to award, the Contract Developer (purchaser) must check the divestment lists to determine if the potential awardee is in violation of this requirement. The divestment lists are maintained by the Texas Safekeeping Trust Company and posted to the CPA website located at Comptroller. Texas. Gov. If the business is in violation, the contract may not be awarded to that vendor. TEX. GOV'T. CODE 2252.001(2) and TEX. GOV'T. CODE 2252.152.
