The application will be for up to \$300,000 of grant funds to carry out first-time sewer improvement projects benefitting residents of the Doughty & Mathis/Manning Colonia in the City of Rockport's service area. (Kossuth & Doughty

Street areas)

Motion was made by Commissioner Casterline and seconded by Commissioner Olsen to approve an Interlocal Agreement between Aransas County and the City of Rockport for the grant application to the Texas Department of Agriculture's 2019-2020 TxCDBG Community Development Fund contract to construct improvements to the city's public sewer system benefitting the Doughty and Mathis/Manning Colonia with the City's extraterritorial jurisdiction (ETJ).

- 29. Motion was made by Commissioner Olsen and seconded by Commissioner Casterline to approve Accounts Payable and Payroll/Payroll Liabilities.


