LOCAL GOVERNMENT CODE SEC. 111.0675, NOTICE IS HEREBY GIVEN THAT ARANSAS COUNTY WILL HOLD A **PUBLIC HEARING ON THE 2024 BUDGET AT 9:00AM, TUESDAY, SEPTEMBER 5, 2023** IN THE **JUSTICE OF THE PEACE COURTROOM**, ARANSAS COUNTY COURTHOUSE, 2840 HIGHWAY 35 N., ROCKPORT, TEXAS. THIS BUDGET WILL RAISE MORE REVENUE FROM PROPERTY TAXES THAN LAST YEAR'S BUDGET BY AN AMOUNT OF \$3,212,223, WHICH IS A 23.20 PERCENT INCREASE FROM LAST YEAR'S BUDGET. THE PROPERTY TAX REVENUE TO BE RAISED FROM NEW PROPERTY ADDED TO THE TAX ROLL THIS YEAR IS \$559,528.
