The Meeting was convened at **9:00 a.m.** at which time a quorum was declared by Judge Mills, WHEREUPON, the following proceedings were had and done to wit:

ITEMS FOR DELIBERATION AND/OR ACTION

1. Motion was made by Commissioner Olsen and seconded by Commissioner Chaney to approve moving forward on an agreement with Elsley LLC, regarding housing in Aransas County including a Chapter 381 tax abatement incentive payment agreement in exchange for affordable housing, based on 10 units at 51% of the housing being low to moderate income housing at approximately \$170,000 which equates to 120% of the Metropolitan Statistical Area (MSA) of Corpus Christi, unless the loan requires 115%, for a period of 10 years, to include a schedule of Calendar Years "2019" to "2028" starting at 100% down to 70% for the repayment of taxes.

with Rockport Harvey Housing, LLC, regarding housing in

Aransas County including a Chapter 381 tax abatement incentive


4. Motion was made by Commissioner Olsen and seconded by Commissioner Stiles to approve Accounts Payable and Payroll/Payroll Liabilities.
