On the 3rd day of August, 2015, there was a Regular Meeting of the Commissioners' Court in the Courthouse, Rockport, Aransas County, Texas, with the following members present: C. H. - 14. Discussion on the 2016 Preliminary Budget included:
 Lezlie stated that she had met with Judge Mills and they went over some changes. Most departments were pulled and scheduled for appointments for the Budget Workshop on Wednesday. After she obtains

the Effective Rate Property Division from Jeri Cox, she can find out where the County stands. She also stated, I think I have pulled all I can from expenditures.

Sheriff Mills commented on the increase of the Federal Population in the jail, they fell under a backlog with the DPS lab, but there is a plan in place to address the problem and go forward.

Judge Mills stated that we have cut just about all we can from the budget, but we have budget workshops scheduled. We are trying to come up with some thoughts we need for private services that are necessary for county residents, without going up on taxes that much, if any. It's not going to be easy, but we are still working on it and will try do everything we can for the good of Aransas County.

The court did not enter into closed session.
