Norma Martinez with The Rockport Pilot asked what the final bid was on the Cedar Bayou/Vinson Slough Project. Commissioner Smith replied \$6,698,256.00. Ms. Martinez also asked Judge Mills if he had discussed the proposed tax abatement with the School. Mills replied the school and Rockport and Fulton. Martinez requested the Court to allow her to ask further questions after closed session.
