ENVIRONMENTAL HEALTH ACTIONS

Director of Environmental Health Jackson reported Coastal Bend Home Builders did not follow the permit they were issued when they built the house at #1 Scallop Lane. It is in a hazard zone and is 7.2" below permit. The consensus of the Court was to reevaluate the current process of issuing permits for new construction and consider a larger fine in the future for violations.

Motion was made by Commissioner Smith and seconded by Commissioner Chaney to approve actions of Environmental Health Department to be taken in response to violations of the Aransas County Floodplain Management and Watershed Protection Order regarding property located at #1 Scallop Lane; \$1,800.00 fine and notice in deed records.
