# BIDS - AGRILIFE EXTENSION BUILDING

A lengthy discussion was had regarding the bids for the new Agrilife Extension Building. The Naismith Engineering representative recommended the low bidder Abeco Contracting, Inc. and Infinity Communications for the Alternate 2 wiring. Commissioner Smith asked Road Engineer Vyoral what his opinion was on the price of Alternate 1 - two-course asphalt roadway. Vyoral indicated his department could do it for a much lower price. The base road material was included in the total base bid so only the asphalt would be needed. Vyoral asked how much area there was but the Naismith representative did not have an answer off the top of his head. Agricultural Agent O'Brien stated a demonstration kitchen, including an island, had been requested from the beginning of discussions. The island is not

# PRESS QUESTIONS

Norma Martinez with The Rockport Pilot referred to item #2 on the agenda. She asked who reviewed the revised architect's plans on the Agrilife Building. Commissioner Casterline replied that he got some of the revisions over the email.

She also asked why the County wasn't considered for the parking lot since they do interlocal agreements with local entities to do their roads. Commissioner Casterline replied that Vyoral informed him they are not competitive on doing base they are geared more to large jobs but could do the seal coating.

On item #8 regarding the IT Department, Ms. Martinez asked if promotions should have been brought to the Court (Justin Cook was promoted to IT Director and Collin Jackson to Assistant IT Director). Judge Mills replied "maybe should have."

On item #13 regarding the tree ordinance, she suggested it should not be approved before the final document is approved. Commissioner Murph stated it can be approved at any time but has not taken effect. Ms. Martinez then asked when it will be taking effect. Judge Mills replied at the first meeting in February the Court will be setting the effective date.
