REGULAR MEETING - NOVEMBER 8, 2010

At present, she is researching for location for such a project and asked for the Courts permission to continue studying the need for a Community Garden.

This project has already been turned in but she needed to come before the Court to present clarification in the verbiage of the agreement. the Court on a motion by Commissioner Casterline and seconded by Commissioner Smith voted to approve the intergovernmental agreement between Aransas County and the City of Rockport related to the disaster recovery supplemental round 2 phase 1 application.
