REGULAR MEETING - December 9, 2013

On the 9th day of December, 2013, there was a Regular Meeting of the Commissioner' Court in the Courthouse, Rockport, Aransas County, Texas, with the following members present: C. H. Other County Officers present were Richard Bianchi, County Attorney; Lezlie Kirk, County Auditor; Jerry Brundrett, County Surveyor; Alma Cartwright, County Treasurer; David Vyoral, Road Administrator; and Bill Mills, Sheriff.

MINUTES

Motion was made by Commissioner Smith and seconded by Commissioner Casterline to approve the minutes of the Regular Meeting of November 25th, 2013.

REFUGIO-TAFT HIGHWAY

David Vyoral indicated this part of the highway would be an evacuation route for about 50 homes. The material cost is approximately \$40,000. Commissioner Chaney would like him to ask the company that whose trucks use this route to help with the expense. Mr Vyoral said he would ask.

Motion was made by Commissioner Chaney and seconded by Commissioner Casterline to approve authorizing Road and Bridge Department to improve approximately one mile of the Refugio-Taft Highway.

LIVE OAK ELEMENTARY PARKING ON GRIFFITH

David Vyoral approached the Commissioners with a map of what is proposed. Sheriff Mills also approached the Court. There was a discussion as to this not being a long term solution to the problem of parents dropping off students. Several on the court thinks ACISD should present a better and safer solution to the problem.

Motion was made by Commissioner Chaney and seconded by Commissioner Casterline to approve use of a portion of Griffith Street for construction of parking in front of Live Oak Elementary under terms of existing Intergovernmental Agreement with Aransas County Independent School District (ACISD).

Question. The motion failed with Judge Mills, Commissioner Smith and Commissioner Stiles voting against.

'NO PARKING SIGNS' LIVE OAK ELEMENTARY

Motion was made by Commissioner Chaney and seconded by Commissioner Casterline to approve installing 'No Parking Signs' along the East edge of the southbound lane of Griffith Street in front of Live Oak Elementary.
