Pat Rousseau, Human Resources, stated TAC is going to increase medical coverage under general liability to cover volunteers. There will be no increase in premium.

Motion was made by Commissioner Smith and seconded by Commissioner Casterline to approve removing changes to workers' compensation coverage approved November 13, 2012 for 2013 to revise policy regarding volunteers.

DRAINAGE IMPROVEMENTS

Motion was made by Commissioner Stiles and seconded by Commissioner Casterline to authorize Drainage Engineer to negotiate with property owners for reasonable compensation (fair market value) for land acquisition as necessary to continue prioritized drainage improvements identified in the 2011 Capital Improvement Plan with such agreements being reviewed by the Storm Water Management Advisory Committee and recommended for approval by Commissioners' Court before being finalized.

FENCE - FIRING RANGE

Motion was made by Commissioner Smith and seconded by Commissioner Casterline to approve request of County Sheriff for permission to erect an 8-foot fence enclosing the open side of the berm for the firing range at the County yard on FM 2165 with expense for same to be funded by the Sheriff's Department operating budget or forfeiture fund contingent on Sheriff coming back to the Court with a cost estimate.
