WALMART GRANT FUNDS - LIBRARY'S SUMMER PROGRAM

PRESENTATION - ACMSI (EMS)

Aransas County Medical Services, Inc. representative Kathy Farmer provided an update from 2008 to present on operations and expectations for upcoming 2012 year. She asked the Court to consider a 10% increase in the County subsidy for 2012. Both Commissioner Chaney and Commissioner Smith felt this would not be enough to maintain their budget suggesting the County may need to look into an Emergency Services District. Commissioner Smith stated it would require approval from the voters and would, if passed, possibly be a one to one and one-half cent tax increase.

CONTRACT/SERVICE AGREEMENT - ENGINEERING

Commissioner Smith questioned Naismith representative Craig Thompson regarding the difference between the original CIP of \$160,000.00 and this agreement asking if this was going to be indicative of the CIP plans. Mr. Thompson stated the additional cost was directly related to the Corps of Engineers permitting fee. Commissioner Chaney also asked what had changed since the original cost was given to the Court and Mr. Thompson stated they had made a mistake in their figures.

Motion was made by Commissioner Smith and seconded by Commissioner Chaney to approve contract/service agreement with Naismith Engineering, Inc. in the amount of \$187,500.00 for the engineering, design and preparation of construction documents for the Mesquite Bypass Drainage Improvement Project.

CERTIFICATES OF OBLIGATION
