PRELIMINARY 2012 BUDGET

County Auditor Kirk presented a new proposed 2012 budget with a table of contents and a budget summary of the 2012 General Fund. Commissioner Smith stated the increase in fringe benefits needs to be looked at. Health care costs are up 22%. Commissioner Smith asked County Treasurer Oliver what can be done to address

this problem. Ms. Oliver stated the County could go out for bids to see if there are any lower priced insurance companies offering the same benefits the County currently has. It has been several years since this has been done. Discussion was also had regarding the jail commissary funds. Sheriff Mills informed Ms. Kirk there is an Attorney General opinion stating these funds do not go to the General Fund. Commissioner Casterline stated the expenses should go with the income; if the commissary is getting the income, they should also be paying the costs. Commissioner Smith also asked Ms. Kirk how much income should be budgeted in jail transportation; she stated \$60,000.00 to \$70,000.00.

2011 EFFECTIVE & ROLLBACK TAX RATES

Tax Assessor-Collector Cox presented the notice that will be published in the Rockport Pilot on August 3, 2011. The 2011 effective tax rate is \$0.37025. Any rate over the 2011 effective tax rate requires two (2) public hearings. This is an increase from the 2010 rate of \$0.359783. The 2011 rollback rate is \$0.415033.
