The Court entered into closed session at 9:59 a.m. as authorized by Texas Government Code Section 551.072 to discuss real estate negotiations, including Pathways Projects; and to discuss with County's legal counsel potential litigation pursuant to Texas Government Code Section 551.071(1)(a) and other matters covered by attorney-client privilege pursuant to Texas Government Code Section 551.071(2); and resumed Open Meeting at 11:02 a.m. with all members present, and further proceedings were had and done to wit:

SUCCESSOR COUNTY ATTORNEY AFTER PRIMARY

Judge Mills stated, "The Court has discussed with our legal counsel the appointment procedure for the County Attorney position, and I believe we should defer any action pending the outcome of the electoral process. In the meantime, I personally reject the threats of action and feel that my decision is in accordance with my legal responsibilities under *Government Code Section 87.041*. Additionally, if the District Attorney wants to file a lawsuit against someone, I feel he should just file against the Commissioners' Court."

Commissioner Smith asked the following taken from a letter dated February 6, 2014, from County Attorney Richard P. Bianchi be entered in the Court's minutes - "You have and continue to act in accordance with the law. However, a change of circumstances may be nearing that should be considered. There is no candidate in the Democrat Primary, so the winner of the Republican Primary on March 4 will be the likely replacement. When you are able to determine the final winner of the Republican Primary, that such candidate is able to assume office, and also reasonably determine there will be no independent candidate, circumstances warrant a reassessment of appointing my replacement." Smith also stated Commissioners' Court has had a history of appointing candidates when there is no other candidate for a position.

Commissioner Chaney told the Court Ector County has a kiosk outside

the Courthouse that allows a person to make payments after hours. He asked IT Director Collin Jackson to look into this for our County.

Commissioner Stiles reminded everyone that LaMardi Gras is this weekend in Lamar.

Commissioner Chaney said the quality of road work done by the Road and Bridge Department was very visible at the new Lamar Fire Station.
