### Aransas County Alliance Local Government Corporation

Minutes of the meeting of the Board of Directors held at the Aquarium Education Center on Monday May 2, 2022 at 11:00 a.m.

- I. Roll Call and Confirmation of Quorum- Judge Mills, Mayor Rios, Mayor Cole and Director Jeff Hutt were present and the meeting was called to order with a quorum at 11:00 a.m. Also present were Michael Meek, John Jackson, Collin Jackson, Mike Probst, Pat Rousseau, Tommy Moore, Diane Probst, Barbara Gurtner, Randy Freeze, two unidentified citizens and John Bell via zoom.
- II. Citizens to heard- No citizens spoke during this item

#### III. Consent Agenda

1. The minutes for the January 31, 2022 meeting were considered. Mayor Rios made a motion to approve the minutes with a second by Mayor Cole. **Motion approved 4-0** 

#### IV. Regular Agenda

- Discuss, deliberate and take action on the ACPEDC 1<sup>st</sup> Quarter Report- Meek presented a slide show outlining activities of the EDC in January, February and March. Mayor Rios made a motion and Mayor Cole seconded it. <u>Motion approved 4-0.</u>
- 3. Discuss, deliberate and take the following possible actions concerning the future utilization of Aransas County Alliance Local Government Corporation (LGC), in view of the adoption of economic development policies by both Aransas County and The City of Rockport- Mayor Rios stated this was his agenda item as he had been discussing this with the city manager and other for some time. Originally conceived by legal counsel to enable grants to the LGC and then on to the EDC, the LGC has become a hindrance and extra layer of bureaucracy according to Mayor Rios. He added that the inter-local agreement between the entities terminates his December and action today in this item sets in motion a process for it to be properly considered by all the member entities. Jeff Hutt stated he has not had the opportunity to fully discuss this with the Navigation District. John Bell was asked by Judge Mills to explain the item. Bell agreed that it does expire this December 9<sup>th</sup> and was an extra layer of government.
  - A. Judge Mills read 3A: Terminate the Economic Development Services Agreement with the Aransas County Partnership Economic Development Corporation (EDC) effective as of December 31, 2022, so that the EDC may contract with participation entities directly. Jeff Hutt moved to table item 3A. There was no

second to his motion, Mayor Cole moved to approve Item 3A with a second given by Mayor Rios. Cunningham stated that each entity would need to vote to terminate the LGC. He was informed the LGC was not being terminated. Jeff Hutt inquired about the formation of the LGC and Bell stated it was a vehicle post-Hurricane Harvey to allow business and individuals to provide land and other items to the LGC that could be utilized by the EDC in economic development creation. After several other comments from Jeff Hutt, Mayor Rios called the question. Motion approved 3-1.

- B. To maintain the Aransas County Alliance Local Government Corporation on an ongoing basis with annual meeting as necessary to keep the LGC available for special projects that can utilize its statutory powers. Jeff Hutt inquired as what those powers were. Bell answered that it could lease and or own property, issue bonds and other items allowed by state law. Bell ended by stating this action would start the process with the member governmental entities. Mayor Rios moved to approve with a second given from Mayor Cole. **Motion approve 3-1.**
- 4. Jeff Hutt asked Judge Mills to remove Regular Item 4, which was to discuss, deliberate and appoint an Aransas County Alliance Local Government Corporation Director, to be responsible for recording and distribution of the minutes of the Aransas County Alliance Local Government Corporation Board of Directors meeting.
- 5. Discuss and deliberate the need for participating entities to invoice the Aransas County Alliance Local Government Corporation for administrative service. Jeff Hutt stated the LGC needed to reimburse the county for services to the organization. Judge Mills inquired to Mr. Bell for his thoughts. Bell stated that the by-laws allow for member entities to provide services to the LGC.
- 6. Discuss and deliberate entering into negotiations with the Aransas County Independent School District (ACISD) to join the Aransas County Alliance Local Government Corporation. Jeff Hutt stated he had spoken to the school board member and there was interest. Bell was asked by Judge Mills about this and Bell added that independent school districts are not allowed to join local government corporations. Mayor Rios added that the school district had been asked to join back in 2019 and had declined. Jeff Hutt stated that his agenda item was moot.

- 7. Discuss and deliberate the Aransas County Alliance Local Government Corporation's current contract for economic development services with the Aransas County Partnership Economic Development Corporation. Jeff Hutt asked Meek if the EDC would pay more attention to the Navigation District's assets in the county. Meek stated that the EDC invites the Harbormaster for the Navigation District to their board meetings. Meek added that they had recently offered the EDC funds to market Navigation District assets and that it was turned down. Moore inquired who had turned the funds down and Meek answered the Harbormaster.
- V. Reports and Announcements from Directors: There were no reports or announcements to be given.
- VI. Adjournment Motion was given by Mayor Rios seconded by Mayor Cole to adjourn the meeting. <u>Motion approved 4-0</u>. Judge Mills adjourned at 11:58 a.m.

Section 1. The Board of Directors hereby approves the form of Amendment to the Articles of Incorporation/Certificate of Formation for the Corporation, a copy of which is attached as <u>Exhibit A</u> to this Resolution, and such shall be submitted to the sponsoring entities for approval. This Resolution shall constitute the written application of the Corporation seeking such approval.

Section 3. The Board of Directors hereby additionally approves the form of Amendment to the Bylaws of the Corporation, a copy of which is attached as <u>Exhibit B</u> to this Resolution and such shall be submitted to the sponsoring entities for approval. This Resolution shall constitute the written application of the Corporation seeking such approval.

#### EXHIBIT A

#### AMENDMENTS TO ARTICLES OF INCORPORATION/CERTIFICATE OF FORMATION OF THE ARANSAS COUNTY ALLIANCE LOCAL GOVERNMENT CORPORATION

These Amendments to Articles of Incorporation/Certificate of Formation of the Aransas County Alliance Local Government Corporation (the "Corporation"), a public nonprofit corporation formed under Chapter 431 of the Texas Transportation Code, are made by the Corporation and approved by Sponsoring Entities of the Corporation who have elected to continue participating in the Interlocal Agreement to be effective on the last date signed. The Articles of Incorporation/Certificate of Formation are amended as follows:

1. <u>Article VII</u> shall be amended to read as follows in order to update the registered office and agent:

#### **ARTICLE VII**

#### **REGISTERED OFFICE AND REGISTERED AGENT**

The street address of the registered office of the Corporation is the Aransas County Courthouse, 2840 Highway 35N, Rockport, Texas, 78382, and the registered agent shall be C.H. "Burt" Mills, Jr., County Judge, or his successor in office.

2. The first paragraph of <u>Article IX</u> shall be deleted in its entirety and replaced with the following in order to match the number of Directors with the number of Sponsoring Entities from time to time:

#### **ARTICLE IX**

The affairs of the Corporation shall be managed by a Board of Directors which shall be composed in its entirety of persons appointed by the governing bodies of the Sponsoring Entities, with each such Sponsoring Entity appointing an equal number of Directors.

3. The last paragraph of <u>Article IX</u> shall be deleted in its entirety and replaced with the following in order to provide for flexibility in the number of Sponsoring Entities:

Directors shall be appointed for terms of two (2) years, in accordance with the Bylaws and may be appointed to successive or non-consecutive terms. There are no term limits for service on the Board of Directors. A Sponsoring Entity may

remove its appointed director from the Board of Directors at will, for any reason or no reason at all, in accordance with the Bylaws adopted by the Corporation and approved by the governing bodies of the Sponsoring Entities. The directors shall serve without compensation. If the Corporation has funds available, the Corporation shall reimburse directors for actual expenses incurred in the course of performing director duties

#### Section 3.1 Powers, Number, and Term of Office.

(b) The initial Directors approved by the Sponsoring Entities to establish the Corporation and approve the Articles of Incorporation consisted of four (4) directors. Upon adoption of these Bylaws, the Board of Directors shall be appointed by the governing bodies of the Sponsoring Entities of the Corporation.

2. Section 3.2(a) of the Bylaws shall be deleted in its entirety and replaced with the following in order to change from quarterly meetings to annual meetings:

#### Section 3.2. <u>Regular Meetings</u>.

(a) Regular meetings of the Board of Directors shall be held at least annually as shall be designated, from time to time, by resolution of the Board of Directors.
